

Convictions are our belief systems that give rise to our opinions. Convictions are about what matters to us, what we believe and so, we imply. This is the sole reason that a conviction always feels so certain, so right, even when it's not yours. Why is it, that when our 'convictions' are questioned, we grab at every possible reasoning, desperate to justify them? A lot of the time, when one's conviction is threatened, they refuse to let it get shot down, simply because it creates a sense of betrayal of self.

Conviction has such a strong hold on its holders that people consciously sacrifice it all-including logic and reasoning, just to hold true to their identity. Contrary to popular belief that they're just illogically stubborn opinions, convictions are so much more. Conviction helps one to take a stance and have enough belief to stand by it. Nine-year-old Zorawar Singh and seven-year-old Fateh Singh ultimately empowered their religion, their culture and their kingdom by refusing to convert, even with death so close. Their portrayal of personal conviction best describes what we must embed in ourselves through the theme of August.

The sheer willpower of the royal Sikh princes shines through their adamant refusal to convert from Sikhs to Muslims. Aurangazeb, having bribed the family cook of Guru Gobind Singh (father of the princes), captured the two young boys and forced them to convert. He promised the boys "freedom" and safety only if they left behind their religion and took up Islam as their new identity. Headstrong princes though, Zorawar Singh and Fateh Singh rejected without hesitation and were bricked alive and hence died from suffocation. Their conviction and utter belief in their religion and culture, and knowing that converting would mean giving up what they'd been fighting for all this while, they chose death over Aurangazeb's 'freedom'. But how does this conviction relate to us, mere students of the current generation?

As a student, conviction is a way of life. Gurudev used to travel across the globe to give lectures. He also used to manage the Chinmaya Mission's administration till he attained Mahasamadhi at the age of 77 years. There is an incident in the life of Gurudev that many devotees recollect even today.

Once, while visiting a foreign country, he was staying at a devotee's house. After settling in his room, he asked the host, "Where is my pooja samagri?" The puzzled host family looked at each other, unable to understand what Gurudev wanted.





Then Gurudev smiled and said, "My pen, paper and table for writing letters". He considered his work for the Chinmaya Mission as 'Pooja' of the Lord.

Once, Gurudev suffered from knee pain. Seeing his plight, devotees wondered how he would be able to sit and work at the table. For which he said, "I keep my legs under the table, and work over it."

Even in the worst of situations, he would find something positive, and often took to wit and humour to ease the situation. When he went through a bypass surgery, the doctors observed that his heart had enlarged. To this, Gurudev laughed and said, "Now I have a large heart. I can accommodate more people!"

Malaysia to procure 18 Tejas jets from India: Australia, US and the Philippines show interest as well.

Malaysia has asked for 18 Tejas LCA (Light Combat Aircraft), made by the Indian-Run Hindustan Aeronautics Limited, for which HAL has offered its twin-seater variant. Other countries including the US, Australia, Indonesia and the Philippines have also shown interest. According to the Minister of State for Defence Ajay Bhatt, New Zealand and Egypt have also evinced interest. Last year, the Indian Government had signed a 48,000 crore deal with HAL in order to acquire 83 Tejas jets for the Indian Air Force.

However, many still do not know about the tragedy that befell him during the height of his career. Despite this, he still strove to do more, and accomplish more. Lauda's determination and drive is thoroughly inspiring.

COMEBACK OF NIKILAUDA

Niki Lauda, now remembered as a 3 times world racing champion became an inspiration because of his sheer determination to conquer death, to not give his arch-rival James Hunt a free championship title

But what happened to him?

Fresh from winning his first driver's world championship with Ferrari. Niki and Ferrari entered the 1976 season as the favourites to win the championships. Niki had won 5 races already and was leading the championship with a healthy lead, by the time the F1 circus reached Nürburgring, the 10th race of the season. Niki did not want the race to go ahead as planned due to treacherous weather conditions. But every other driver wanted to race, in particular, his rival James Hunt wanted to race. He criticized Niki for being "scared" to race, even though Niki had won the last year's grand prix.



Disaster struck on the second lap of the race itself. Massive flames rose up from the car's chassis, buffeting Niki Lauda. Lauda was pulled from the wreckage, barely escaping with his life. After having inhaled noxious gases and sustaining burns that cost him his eyelids, half an ear, and large portions of his scalp, it was clear that his racing career was over.

Immediately after the accident on August 1, 1976, Audetto was ordered to find a replacement for Lauda, and the team signed up racer Carlos Reutemann to partner with Clay Regazzoni.




But come early September and Lauda was out of hospital, insisting on testing for Ferrari at Fiorano to ready for a return at Monza, in front of a skeptical Enzo Ferrari. "When he arrived, that is a vision that I can never forget in my life: Niki arrived in Fiorano with his plane that he apparently [flew] himself to come to Bologna. He was so pale, had plenty of scars, had lost his hair, he could not close his eyes – he was like a ghost!" recalls Audetto. "He was very cool, very cold, very determined. He went into the Fiorano office to get the overalls; he came out with the overalls that were very large because he lost 10 kilos."

Racer Niki Lauda had all the reason in this world to quit racing and give up everything after a near-fatal accident like that. However, he chose to continue. He chose to persist. And that is determination. And that is what we must all strive for.


LOGICAL FALLACIES by Adhavan Diwakar

A perfectly structured logical argument. How many of us don't love that? You're arguing with someone, and you give the perfect logical rebuttal, shutting everyone up and proving your point. But, what if your perfectly structured logical argument wasn't perfect? What if it had a hidden flaw, buried deep within? Nobody would know, but in reality, your argument, the one you were so proud of, the one that made everyone think you were a genius, is flawed.

This is a problem that has plagued arguments for centuries. A seven-letter word that could so easily invalidate any argument, Fallacy. A fallacy arises when flawed logic is used in the construction of an argument, either intentionally or unintentionally. It is often hidden in the logical deduction process, and is quite hard to spot. A fallacy makes an argument look convincing, but once the fallacy is spotted, it crumbles. Let us try to understand what a fallacy is, by working out a simple problem.



Fallacies aren't present only in obscure mathematical proofs, involving calculus, advanced number theory, Newton, Leibnitz, and god knows who or what else. They affect our everyday lives, and every field from medicine to international politics have had fallacious arguments.



Eisenhower's statement seems plausible. The "domino effect" that he states makes sense doesn't it? After all, it seems only natural that once one country comes under communist control, the countries around it would also come under communist control, and the dominoes would continue falling, until the entire world came under authoritarian communist regimes. Let's do some quick math. Assume there are 20 events, all independent of each other. Assume that each event is 99% likely to happen. The probability that the first event would lead to the 20th is;



$$(99/100)^{19} = (0.99)^{19} = 82\%$$

What happened there? How did the probability drop from an almost certain 99% to a mere 82%? However, it turns out the results only get more surprising. Let us consider the end probabilities when the probability of each event is 95%. The final probability ends up being only 37%.

Those numbers are far from the numbers you'd expect after Eisenhower's speech. Turns out Eisenhower's deduction process suffered from a type of fallacy called a slippery slope fallacy. A slippery slope fallacy is when someone presents an event, say x, as an inevitable outcome of a series of events. However, slippery slopes almost always overstate the likelihood that x will happen if the first event in the sequence happens. Let's cycle back to the previous example. Eisenhower feared a series of events would unfold, and would eventually threaten the United States. Those events were:

Communist takeover in Vietnam would spread communism in neighboring countries. With no non-communist countries left to trade with, Japan would adopt communism. Finally, the situation would then threaten Australia, New Zealand, and eventually, the United States

Slippery slope arguments assume that events work like dominoes, that once an event happens, it will trigger another event, and so on, until the final event takes place. However, events like these can have many possibilities and outcomes, and behave more like a web than a chain. In fact, the first event that Eisenhower predicted could not be stopped. In 1975, South Vietnam fell, and a communist state under Ho Chi Minh took over. Communist regimes also came up in neighboring Laos and Cambodia. However, his end result was far from the truth. By 1991, the Soviet bloc had fallen, and communist countries would continue falling until only a nominal amount remained. Isn't it truly amazing how one small line of error, placed in the deduction process, could change the final outcome? Fallacies remain a thorn in the side of anyone constructing and listening to logical arguments, and they can never be truly eliminated.

A line by Stephanie Klein sums up fallacious arguments quite well - "Tell the truth, or someone will tell it for you."

It may not come as a surprise to whoever has been to a toy shop to buy a gift for a child, to be asked the question, 'Is it for a boy or a girl?'. Remote-controlled cars and construction kits that are solely meant for young boys and kitchen sets or doll houses that are reserved for girls, these casual gender stereotypes seep their way into everyone's daily lives, especially when you are a student.

Gender Stereotyping is defined as the practice of ascribing to an individual woman or man specific attributes, characteristics, or roles by reason only of her or his membership in the 'social group' of women or men. Restricting one based on their gender impacts the subject choices, and career aspirations. This in turn impacts their adulthood especially in their workplace, household, level of seniority, pay, etc.


These are questions that we must learn how to ask. Questioning conventions is the first step to defying gender stereotypes.

Underlying gender restrictions are found in every environment and blindly accepting them, means carrying them into our future and enforcing the same on the forthcoming generation. There's nothing wrong with asking questions, there is nothing wrong with wanting to understand what someone means when they restrict something to your gender.

Sedition is classified as conduct or speech inciting people to rebel against the authority of a state or monarch. A word used liberally in current times, this article offers insights into the various arguments to and for the sedition laws which exist around the world. Through this we strive to revive the time honoured tradition of debate and discussion in order to bring out opposing perspectives to the forefront and understand the core ideas which drive human society.

man rights activist' Arundhati Roy shared the stage with Kashmiri separatist leader Syed Ali Shah Geelani from the Hurriyat and Maoist sympathizer, Varavara Rao in a conference titled 'Azadi-the Only Way'. In her speech, she mentions that 'Kashmir was never an integral part of India' and goes on to back 'Kashmiri separatists' in their pursuit for 'Azadi' (Independence). In fact, she criticizes the Indian Army for apparently 'committing atrocities against Kashmiris and Maoists'. Ironically, this meeting was held at the Indian capital of New Delhi and unsurprisingly, she was charged under sections 124A (sedition), 153A (promoting enmity between classes), 153B (imputations, assertions prejudicial to national integration), 504 (insult intended to provoke breach of peace) and 505 (false statement), rumours circulated with the intent to cause mutiny or offence against public peace.

While many may say that it's her freedom to advocate for Kashmiri separatism under Article 19 of the Constitution, her statements offer an endorsement for Pakistan-backed terrorists in Kashmir who are working for the same cause that Ms. Roy advocates for and attempting to destabilize the Indian state. She criticizes the same Indian Army and Indian intelligence agencies under whose protection she lives peacefully in this country devoid of terror attacks and anarchy. As expected, she contested the sedition charges as a violation of her 'Right to freedom of

The problem with people like Arundhati Roy and Varavara Rao lies in their inability to comprehend the fact that the Constitution does not merely guarantee rights, but it seeks the fulfillment of obligations or duties in exchange for the fundamental rights that they enjoy. They violate the most preeminent fundamental duty in the Indian Constitution 'to uphold and protect the sovereignty, unity, and integrity of India'. While they might argue that these fundamental duties are statutory (not enforceable by law), the courts are entitled to take these duties into account when adjudicating on their sedition charges.

On October 21st, 2010, the famous author and so-called 'hu- 20th February, 2020, 19-year-old student activist Amulya Leona was booked under the Sedition Law for raising pro-Pakistan slogans in a protest rally against the CAA. Leona had repeated 'Pakistan Zindabad' thrice, before being taken into custody by the Bengaluru Police and booked under sections 124A, 153A and 153B of the Indian Penal Code (IPC).In this particular case Amulya Leona, however debatable her slogans might have been, had by no means raised disaffection against this country or undermined its stature. This makes us turn back the clock to 1955, the case registered in Supreme Court, of 'Balwant Singh and Another vs State of Punjab' where the Apex Court had held that "The casual raising of the slogans, once or twice by two individuals alone cannot be said to be aimed at exciting or attempt to excite hatred or disaffection towards the Government."

> This bears testimony to the fact that the Sedition Law has been subject to rampant misuse, where Amulya Leona had done no more than just raise slogans. Her Facebook post the previous week brings forth the justification behind her evocation of those slogans: "Whatever country may be long live for all the countries!" She had also written: "Long live India! Long live Pakistan! Long live Bangladesh! Long live Sri Lanka! Long live Nepal! Long live Afghanistan! Long live China! Long live Bhutan!"



Section 124A or the sedition law falls under a larger umbrella of similar provisions in our legal system such as sections 153A (promoting enmity between classes) and 153B (imputations, assertions prejudicial to national integration) to uphold the fulfillment of the fundamental duty stated in the previous paragraph. This particular provision has come under attack for its colonial roots and its growing misuse in the country to suppress dissent. While I condemn the growing proclivity of certain political dispensations to misuse this law, I believe that complete removal of the law would have undesired consequences for our national


The first underlying problem in the argument of my opponent to remove the sedition law is an excessively literal interpretation of Section 124A of the Indian Penal Code which briefly states that 'any attempts to excite disaffection towards the Government established by Law' shall be punished with 'imprisonment for life'. Clearly, this statement looks atrocious especially since it was enacted by Thomas Macaulay in 1860 to suppress dissent against the colonial government. However, a law cannot be removed on the sole basis of its colonial roots and must be measured by its relevance in the modern day.

October 2016, when the BJP-led government proposed changes to the Chotanagpur Tenancy Act of 1908, the tribals of the Kunthi district of Jharkhand perceived their rights to be at risk. As a protest, they engraved the provisions guaranteed by the 5th schedule of the Indian Constitution on stones.

This protest came to be known as the 'Pathalgadi Movement' and led to 10.000 cases being registered under the Sedition Law against the tribals, for invoking the provisions of the Constitution! These cases dish the dirt off the exploitation this law has been hierodule to in the post-independence era. The conviction rate of the Sedition Law, which, matched with the reports provided by National Crime Records Bureau (NCRB), has stretched between 3% to 33% over the preceding years.

The conjecture apparent from this data being that a vast majority of people booked under this law are acquitted and their arrests have been established to be futile. The pendency of such cases has reached an all-time high of 95%. These figures only impress upon us that this law is irrelevant and lingers as a burden in the Constitution of

In fact, this law, which had been drawn up under the dominion of the British Government, had been abolished in Britain itself in 2009, stating that the country didn't want to be identified as an ideal of one using such draconian laws. Pandit Jawaharlal Nehru quoted on the Sedition Law in 1951, "Take again Section 124-A of the Indian Penal Code. Now so far as I am concerned that particular section is highly objectionable and obnoxious and it should have no place both for practical and historical reasons. The sooner we get rid of it the better."

Today was quite an eventful day, even by the afterlife's standards.

I was standing among the crowd that had gathered at the station in wait for the train that would take what the others seemed to call home. The atmosphere was laced with the smell of the sweat of a million people. The silence in the train was broken by an announcement, "Doors closing in on Patriot's Heaven Junction, next stop India Gate." I was not a patriot or anything, I had just tried to get in on a way to escape this mundane life of afterlife for once... India Gate arrived, I had no destination in mind as such. And it is quite obvious, what happens with us nomads, we are just pushed along with the crowd. The pushing and shoving aboard was none less than the local trains of Bombay, and I, being accustomed to this pushing over, landed at a place which had no special significance to me.



I wandered, without any clue or aim until I came across my sole companion, who, like me, stood alone even, when so many people had come together. I knew of his fame, but looking at him after 25 years, gave rise to questions, that had remained unanswered:

Me: You fly to the sky 138 feet high Above where all lie How could you know What we come by The Saffron answered:
You say I am without care and knowledge of my people
I fly high, not to distance myself
But to look on all, to inspire all, to show all
That above all comes a duty
The willingness to sacrifice




